<sup>1</sup> Trigger level is the sum of the base trigger level multiplied by the average quantity of imports during the three preceding years for which data are available and the absolute volume change in domestic consumption of the product concerned in the most recent year for which data are available compared to the preceding year.

<sup>2</sup> According to Article 5 of the Agreement on Agriculture, if domestic consumption is not taken into consideration, the trigger level shall be 1.25 times the average quantity of imports of the previous three years; and regardless of whether domestic consumption is taken into consideration, the trigger level shall not be less than 1.05 times the average quantity of imports of the previous three years. The trigger level of pears, fresh or chilled garlic, dried garlic bulb, betel nuts, chicken legs and wings, fresh milk, livestock offal, red beans, dried shiitake, pomelo, persimmon and pork belly should not be less than 105 percent of the average quantity of imports of the previous three years. The trigger level of garlic bulb for planting, other chicken cuts, other liquid milk and fowl offal are calculated without taking domestic consumption factors into consideration.

<sup>3</sup> The trigger level of peanuts is calculated based on ground-nuts in shell. The imported volume of shelled ground-nuts, flours and meals of ground-nuts and ground-nuts oil should be converted into volume of ground-nuts in shell to accumulate the import quantity of peanuts. Conversion ratios of the above-mentioned goods into volume of ground-nuts in shell are specified in additional notes 3, Chapter 98 of the Customs Import Tariff.

The imported volume of rice in the husk, milled rice and processed rice products should be converted into volume of husked (brown) rice to accumulate the import quantity of rice. Conversion ratios of the above-mentioned goods into volume of husked (brown) rice are specified in additional notes 4, Chapter 98 of the Customs Import Tariff.
