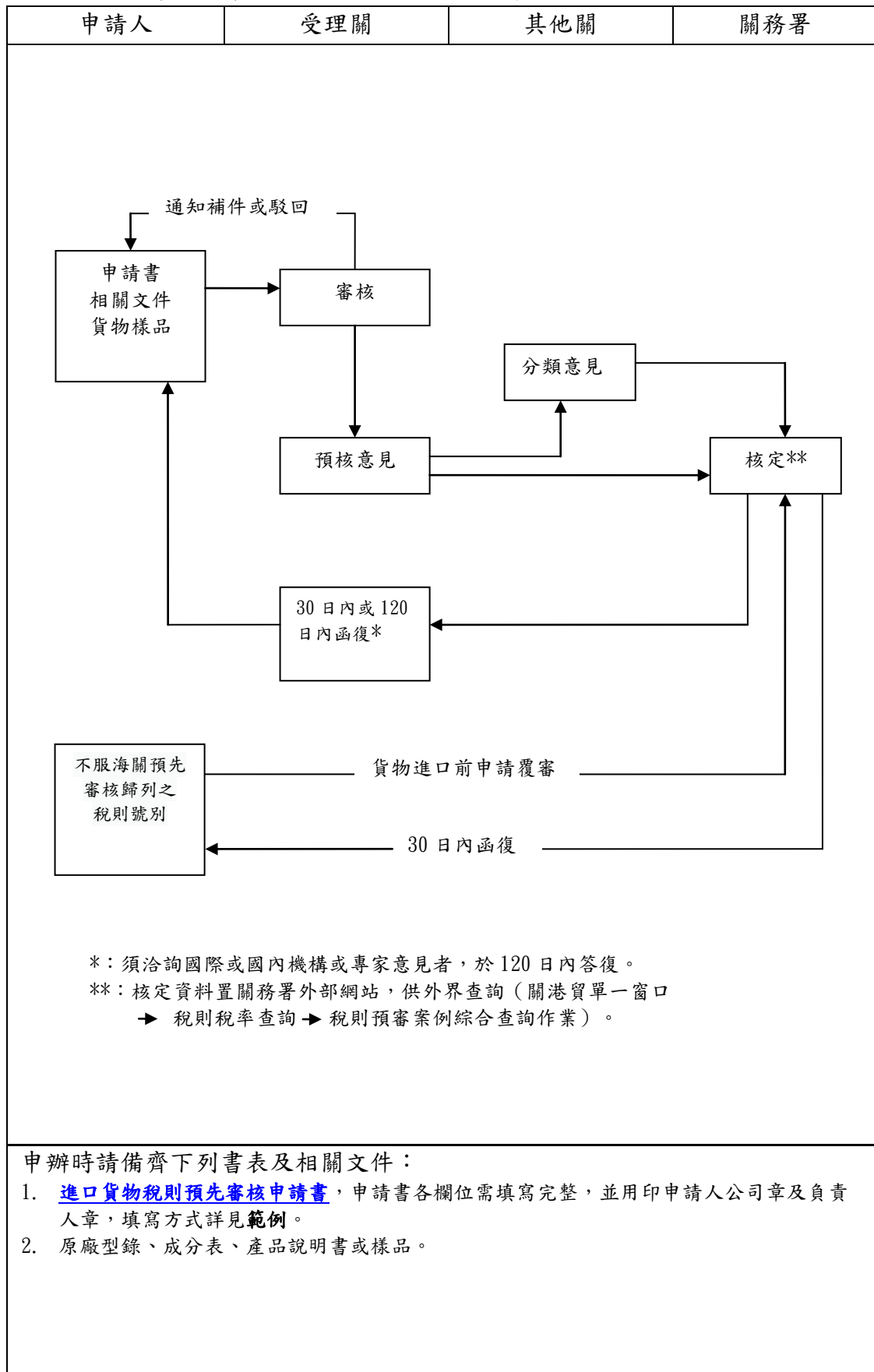

If the actual imported goods are the same as the goods having undergone a tariff pre-assessment, Customs should classify them pursuant to the pre-assessed tariff number.

2. 貨品已通關放行者，如不服進口地海關所核定之稅則，請依關稅法第四十五條規定申請復查，以符程序。

Should the tariff classification ruled by the Customs of the import port is not satisfactory to the taxpayer after the goods have been cleared and released, a request for review can be filed in accordance with Article 45 of the Customs Act.

3. 海關將依申請人意願，並考量保護商業機密之必要性，決定是否公開預先審核案例。

Customs will determine whether a tariff classification advance ruling case should be made public, after considering both the applicant's intention and the need to protect commercial confidentiality.
